9 Quilco is a well-presented two bedroom semi-detached bungalow offering spacious accommodation. The attractive property stands in good decorative order and is situated in a small housing development on the outskirts of Dounby village.

The bungalow has electric heating together with an open fire in the living room which has a back boiler heating the domestic hot water (an immersion is also fitted).

The spacious living room has room for a dining area. There are fitted base and wall cupboards in the kitchen together with a built in shelved cupboard, breakfast bar, cooker hood and plumbing for a washing machine.

The modern shower suite includes a walkin shower cubicle, stylish wash hand basin and W.C. together with a heated towel rail. Both bedrooms have a built-in wardrobe and panel heater.

There is a driveway and lawn to the front with the lawn extending to the side of the house where the garden shed is located. The enclosed rear garden includes lawn and trees.

The amenities in the village of Dounby include a primary school, supermarket, butcher, pharmacy, post office and public house.

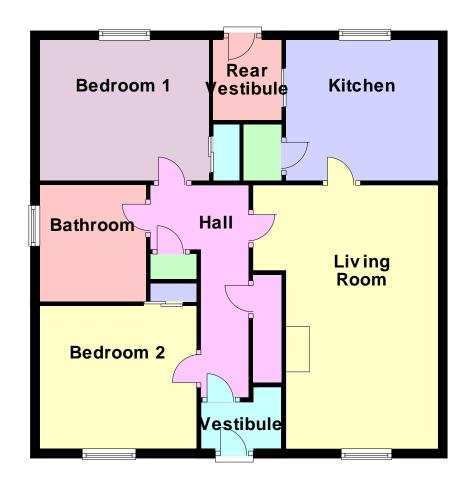

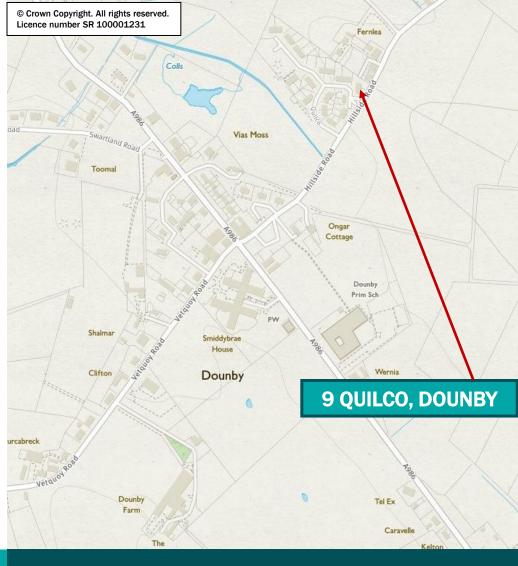
