The accommodation comprises an entrance vestibule with a large under-stair storage cupboard, leading through to a bright and welcoming living room with a large front-facing window creating an abundance of natural light. A hallway leads through to the modern fitted kitchen, which features an excellent range of wall and base units together with integrated appliances and ample worktop space.

On the first floor, the landing provides access to two generously sized double bedrooms, a single bedroom/box room which is ideal as a child's room, home office or study, and a family bathroom fitted with a white suite and an electric shower over the bath.

Externally, the property enjoys enclosed garden grounds to the front and rear, both predominantly laid to lawn, providing attractive outdoor space for relaxation, gardening or family use.

Benefitting from air-to-water heating, external insulation and UPVC double glazed windows throughout, the property provides an energy-efficient home within easy reach of local amenities, schools and transport links.





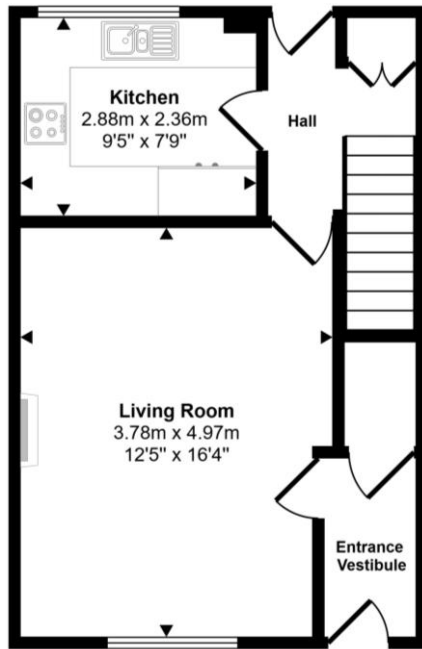
LOCATION

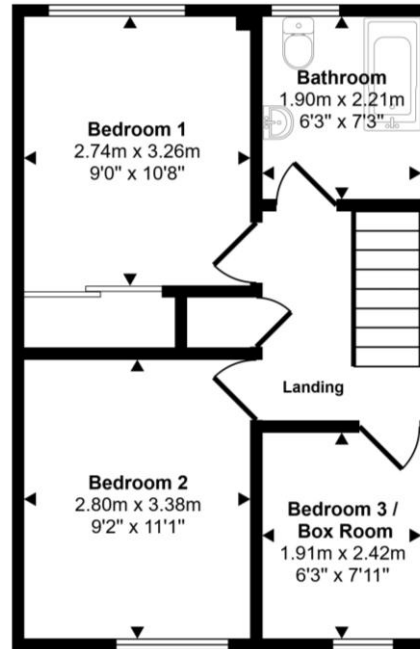
